UFO Research (NSW) Incorporated – By-Laws (Terms and Conditions)

The Committee of UFO Research NSW Incorporated (The Association) resolved to pass the following By-Laws on the 4 April 2009 and as amended on 20 January 2016.

Public meetings include sky-watches, conferences, workshops and other special events organised by the Association.

- 1. The Committee authorises any one or more of the members of the Committee to individually or collectively decline admission to Association public meetings any individual in the Committee member's or Committee members' absolute discretion.
- 2. The grounds for exclusion of an individual from Association public meetings shall include, but not be limited to:
 - a. The contravention of the terms and conditions of entry of any venue at which the Association holds its meetings;
 - b. The individual being intoxicated by drink or drugs in the opinion of a Committee member or members:
 - c. The individual being improperly dressed in the opinion of a Committee member or members;
 - d. The apprehension of a Committee member or members that the individual may disrupt the meeting;
 - e. The apprehension of a Committee member or members that the individual may molest or injure a person, or persons, at the meeting;
 - f. The apprehension of a Committee member or members that the individual may conduct him or herself inappropriately;
 - g. The apprehension of a Committee member or members that the individual may use inappropriate language or express views of an offensive nature to persons attending the meeting; and
 - h. In the opinion of a Committee member or members it is required for the preservation of good order at the meeting.
- 3. The Committee may issue an advance notice to an individual to the effect that they will not be admitted to a particular Association public meeting or to Association public meetings generally, for a period of time or an indefinite period of time.
- 4. The Committee authorises any one or more of the members of the Committee to eject from Association public meetings any individual in the Committee member's or Committee members' absolute discretion.
- 5. The grounds for ejecting an individual from an Association public meeting shall include, but not be limited to, those grounds set out in clause 2 above.
- 6. The Association reserves the right to make alterations to the published meeting location, content and programme, where reasonably necessary.

- 7. Payments (including PayPal) shall be the price at the time the payment is confirmed. The amount is inclusive of any applicable taxes including any booking, collection and delivery fees. No payment will be accepted until we have received full payment.
- 8. Payments (including PayPal) for public meetings cannot be exchanged or refunded after purchase unless the meeting is cancelled, rescheduled or where there is a change to the programme or content. When outdoor events, such as a sky-watch are cancelled due to adverse weather or other unforeseen circumstances, a full refund of any payments made to the Association will be granted.
- 9. Public meetings' refunds for other circumstances, including misadventure, will be approved and granted by the President of the Association.
- 10. Annual membership payment refunds may only be approved and granted by the President of the Association following consideration of the circumstances relating to the application.
- 11. Where a refund is sought you must bring this to the Association's attention as soon as possible.
